

Eden Township Board of Supervisors
Minutes of the December 8, 2014 Meeting

Call-to-Order: Supervisor Ellis Ferguson called the meeting to order at 7:00 pm followed by the Pledge of Allegiance.

Attendance: Supervisors Ellis Ferguson, David Rohrer and David Rineer, also Mark Rudy, Gerry Parker and Szilvia Troutman.

Public Participation: None.

Minutes: The minutes from the November 10, 2014 Board of Supervisors Meeting were reviewed. David Rohrer made a motion, seconded by David Rineer to approve the minutes, motion carried unanimously.

Treasurer's Report: The Treasurer's Report for November 2014, in the amount of \$219,918.29 (attached), was approved unanimously on a motion by Ellis Ferguson and second by David Rineer.

Payment of Bills: The list of bills to be paid in December 2014, in the amount of \$32,122.35, was approved on a motion by David Rohrer, seconded by Ellis Ferguson, motion carried unanimously.

SEO Report: The SEO report listed activity of \$100.00 for the month of November 2014 (attached).

Tax Collector's Report: The Tax Collector's Report listed activity of \$342.87 for the month of November 2014 (attached).

Zoning Officer's Report: Gerry Parker presented the Zoning Officer's Report in the amount of \$1,005.70 for the month of November 2014 (attached).

Road Master's Report: Mark Rudy submitted the Road Master's report of activity in November 2014 (attached). Szilvi will write a letter to residents on Skyview Drive to remind them not to park on the cul-de-sac, so plows can safely pass and turn around.

Old Business:

Omar G. Esh: No payment has been received in settlement of the Magisterial Court's judgment for violating the Green Strip Ordinance. Szilvi will write a letter to Mr. Esh explaining that an order of execution will be filed if no payment is made by December 29, 2014.

New Business:

Fire Company Worker's Compensation: The Supervisors were in agreement with the way Quarryville Borough calculated the portion of fire company worker's compensation premiums payable by municipalities covered by Quarryville Fire Company. Szilvi will email Ken Work regarding their approval and to find out when a bill can be expected for the premium in 2015.

Trust Ordinances To Be Adopted in January: The sample ordinances will be sent to Janice Longer for review.

Direct Deposit: The Supervisors approved setting up direct deposit for all employees on regular payroll. Szilvi will renew the QuickBooks enhanced payroll subscription for \$310 plus the direct deposit fee of \$2/employee/month.

HSAs: Once Mark Rudy and Scott DeRaps set up their Health Savings Accounts, the Township will contribute \$500 each.

Resignation of LeRoy Welk: The Supervisors accepted LeRoy Welk's resignation as Chairman of the Eden Township Planning Commission.

Public Participation: None.

Adjournment: A motion to adjourn the meeting was made by Ellis Ferguson and seconded by David Rineer. The motion was passed unanimously.
