

Eden Township Board of Supervisors Minutes of the June 9, 2014 Meeting

Call-to-Order: Supervisor Ellis Ferguson called the meeting to order at 7:00 pm followed by the Pledge of Allegiance.

Attendance: Supervisors Ellis Ferguson, David Rohrer and David Rineer, also Mark Rudy, Gerry Parker and Szilvia Troutman.

Public Participation: None.

Minutes: The minutes from the May 12, 2014 Board of Supervisors Meeting were reviewed. Ellis Ferguson made a motion, seconded by David Rineer to approve the minutes, motion carried unanimously.

Treasurer's Report: The Treasurer's Report for May 2014 in the amount of \$301,248.46 (attached) was approved unanimously on a motion by David Rohrer and second by Ellis Ferguson.

Payment of Bills: The list of bills to be paid in June 2014, in the amount of \$22,362.27, was approved unanimously, following a motion by David Rineer and second by David Rohrer.

SEO Report: The SEO Report listed activity of \$400.00 for the month of May 2014 (attached).

Tax Collector's Report: The Tax Collector's Report listed activity of \$6,198.87 for the month of May 2014 (attached).

Zoning Officer's Report: Gerry Parker presented the Zoning Officer's report in the amount of \$195.00 for May 2014 (attached).

Following a motion by Ellis Ferguson and second by David Rohrer, the Supervisors unanimously passed an **amendment to Resolution #2014-05-12-01** – the plan filing fees for stormwater exemption applications for projects under 500 sq ft will be \$25.00, while projects over 500 sq ft but less than 1,000 sq ft will be charged a filing fee of \$50.00.

Road Master's Report: Mark Rudy submitted the Road Master's report of activity in May 2014 (attached).

Solanco Public Safety Committee: No report.

Emergency Management: No report.

Southern Lancaster County Inter-Municipal Council: No report.

Correspondence: Received correspondence was reviewed and disseminated.

New Business:

Request for Return of Escrow: On a motion by David Rohrer and second by David Rineer, the Supervisors unanimously approved returning the funds held in escrow for Dennis Arnold (1 Stone Ridge Dr.), contingent on Ed Fisher's approval.

Security System: Following the recent burglary at the shop, Mark talked to Quarryville and Strasburg Boroughs' police chiefs for recommendations on a security system. He will also check about installation costs.

Steel Pod: A steel pod could be purchased from Brad Groff to safely store tools and small equipment, also freeing up space in the shop. David Rohrer and Mark will check out a pod on site.

Concrete Pad: Mark presented a quote for \$2,500 for installing a concrete pad underneath the two fuel tanks and at the garage door (to eliminate water coming in the building). The Supervisors approved having the concrete pad installed.

Adjournment: A motion to adjourn the meeting was made by Ellis Ferguson and seconded by David Rohrer. The motion was passed unanimously.
