Tax Collector's Report: The Tax Collector's report listed activity of \$1,472.42 for the month of December 2022.

Zoning Officer's Report: The Zoning Officer's report listed activity in the amount of \$31,076.05 for the month of December 2022.

The Supervisors discussed Aaron Esh's zoning hearing application (to be heard by the ZHB on January 16, 2023) – the Supervisors had no objections to Mr. Esh requesting more space and employees for his carpeting business at 501 Furnace Rd, leaving the ultimate decision to the ZHB.
